**Application**

University of Helsinki, Faculty of Medicine has applied for a permit to import dog`s and cat`s EDTA-blood, hair and cheek swab samples for research purposes from non-EU countries, including New-Zealand, Australia, Russia, India, China, Japan, US, Canada, South-America, as described in the application.

**By-product category**

Category 1 by-products

**Decision**

The samples are imported for specific research purposes and are exempt from veterinary border control in accordance with Regulation (EU) 2019/2122 article 4

The Animal Health and Welfare Department of the Finnish Food Authority will permit the import on the following conditions:

**Conditions**

1. Each consignment must be accompanied by a commercial document with the consignor`s contact information stating that its contents correspond to those presented in the application. The commercial document must include
  - a) a description of the product and the animal species from which it originates;
  - b) what category of by-product is concerned;
  - c) its quantity;
  - d) the origin of the material and from whence it has been sent;
  - e) the sender`s name and address;

2. If the country of entry into the EU is Finland, this permit and the above documents must be presented to the Finnish Customs.  
If the first country of entry is another EU country, the consignment and documents must be presented at a veterinary Border Control Post of a country in question:

3. The research material must be packed safely and securely and delivered directly to the University of Helsinki / Biomedicum Helsinki, Haartmaninkatu 8, 00290 Helsinki, Finland recipient Prof. Hannes Lohi  
Registration No. FI-EVIRA-OTH-3-2015.
4. The research material must be clearly marked with the by-product category and labelled '**for research and diagnostic purposes**' for the period of transport and storage. The label must be attached to the packaging, container or vehicle.
5. The importer must notify the local supervising official veterinarian when the research material arrives at its destination address, [minna.ristinieni@hel.fi](mailto:minna.ristinieni@hel.fi).
6. The research material is to be used solely for the research purposes outlined in the application and must not be conveyed to others.
7. Users that handle research and diagnostic samples shall take all necessary measures to avoid the spreading of diseases communicable to humans or animals during the handling of the materials under their control, in particular by way of the application of **good laboratory practice**.
8. The research material and any waste thereof shall be destroyed in a manner that does not pose any danger to human or animal health. The material can be either
  - a) incinerated as waste, or
  - b) undergo high pressure sterilization and then disposed of according to Regulation 1069/2009/EU article 12, 13 and 14.

9. Users that handle research and diagnostic samples shall keep a register of consignments of such samples. The register shall include the information in the commercial document referred to in point 1 and the date and method of disposal of the samples and of any derived products. The register has to be given to Finnish Food Authority on request.

**Grounds for decision**

The import does not pose the risk of spreading animal diseases if carried out according to the conditions set out in this decision.

**Period of validity**

This import permit is valid until 23.6.2022. In case of a change in legislation, a new import permit must be applied for.

In cases where legislative changes have an impact on the requirements in this import permit, a new import permit must be applied for.

This import permit shall be revoked with immediate effect if the applicant does not follow the conditions described in this decision or otherwise violates the provisions or regulations set out. The import permit can also be revoked or the conditions changed with immediate effect in case of a substantial change in the animal disease situation of the country of origin or import, or if it is apparent due to some other reason that the import poses an animal disease risk, or if the import poses a risk to human health.

The importer is obligated to duly notify Finnish Food Authority of any changes in their activities that may affect this permit.
